Camp Workshop Goes Green!

The Camp Advisory Committee held its first meeting of the new program year on 10/2/09 to review and evaluate the 2009 Camp Workshop and discuss plans for the 2010 Camp Workshop. For 2010, we are actively exploring having a web based on-line workshop.

While we are still in the preliminary stages of discussion, the idea stemmed from participant surveys as well as committee member feedback. The committee feels by doing a web based workshop we not only help our county and municipal governments in their "green efforts" but we are keeping in step with the technological world we live in. While an on-line program will not be as personal as a live workshop, the committee hopes to have some interactive on-line sessions and videos to view to make it more fun. Of course, cyber attendance is mandatory for all camp operators (attendance verification is still being worked out – perhaps a test or evaluation at the end of each session before you can proceed and/or the completion of your permit application at the very end).

In addition, with the help of the county's IT department, we hope to make this workshop user friendly, educational, enjoyable, and easily accessible to not only camp operators, but directors and any staff that are interested in attending who, in the past, could not attend due to scheduling conflicts.

CAMP CODE UPDATE

The recent changes in Public Health Law that affect the definition of a camp and the permit fee increase for camps will not become effective until the 2011 camping season. This will allow the time needed by the Public Health Council to amend the State Sanitary Code.

The health department will keep us informed of all proposed changes to the camp regulations so that you can submit any comments to the state on their proposals.

In addition, Camp Operators will not be required to submit new computerized safety plans on-line (like pool operators did in 2009).

As more information becomes available we will try and get it out to our membership. You are always welcome to call us should you have additional questions.

Mountain Lakes Park Renamed in Honor of Dr. Sal J. Prezioso

County Executive Andy Spano joined friends, family, WRAPS members and other officials to rededicate Mountain Lakes Park in North Salem in memory of Dr. Sal J. Prezioso, who for 60 years helped shape public policy in Westchester, New York State and the nation, on Wednesday, Oct. 21.

Dr. Prezioso's widow, Sybil, County Board of Legislators Chairman William Ryan, Board Vice Chairman Michael Kaplowitz and County Legislators Peter Harckham, Ken Jenkins and Vito Pinto, County Parks Commissioner Joseph Stout, WRAPS president Dana Mayclim and other invited guests participated in the tribute, during which a new park sign was unveiled. Dr. Prezioso died on Memorial Day 2008 at age 95.

"Dr. Prezioso was a prominent parks and recreation professional for more than 60 years and a nationally acclaimed public administrator," Spano said. "For many in the county he was known as 'Dr. Sal.' For me personally, he was both a mentor and someone I could always turn to for solid advice. Dr. Prezioso

was a visionary who was ahead of his time in identifying the needs of restructuring local governments and school districts for the benefit of all Westchester residents. He is sorely missed. It is fitting that we are rededicating this park in his memory because he was instrumental in the acquisition of this property in the 1960s. Like much of his legacy, this park will benefit Westchester residents for generations to come."

The 1,082-acre park, the northernmost Westchester County park, is open to the public for fishing, skating, boating and canoeing, hiking and nature study, along with many other outdoor activities. The park is also the home of "Camp Morty," a summer camp for underprivileged boys and girls from Westchester's larger urban communities. The camp is named after Morton Hyman, Supervisor of Camping for County Parks from 1957 through 1974.

Dr. Prezioso was born in New York City in 1913. He became parks director for Scarsdale in 1948 and Superintendent of Recreation for the county in 1955. He was also instrumental in bringing about the merger of the parks and recreation departments as a unified Department of Parks, Recreation and Conservation in 1960. While serving as Deputy County Executive from 1962 to 1967, he designed the county's E-911 system and strengthened the government's commitment to establishing a full-time department focused on recreation.
